

This licence agreement (**Licence**) is a legal agreement between you (**Licensee** or **you**) and Cambrionix Limited (company registration number 06210854) of The Maurice Wilkes Building, St John's Innovation Park, Cowley Road, Cambridge CB4 0DS (**Licensor, us or we**) for:

- \* any computer software, code or data provided by us on our website, by email, by file storage device or otherwise (including the Cambrionix API and LiveViewer but excluding our software-as-a-service application known as "Connect") (**Software**); and
- \* associated software documents whether in printed or electronic form (**Documents**).

**IMPORTANT NOTICE TO ALL USERS:**

- \* You warrant and represent that by downloading the Software you do so as a business customer (that is, either wholly or mainly in connection with a business, trade, craft or profession) and not as a consumer.
- \* Further, you acknowledge and agree that consumer regulation (including the Consumer Rights Act 2015, Consumer Protection Act 1987 and the Consumer Contract (Information, Cancellation and Additional Charges) Regulations 2013) shall not apply to this Licence and that you will not be able to rely on any right or remedy as may be contained in such consumer regulation.

## 1. GRANT AND SCOPE OF LICENCE

1.1 In consideration of you agreeing to abide by the terms of this Licence, we hereby grant to you a non-exclusive, non-transferable, licence to use the Software and the Documents only for the Permitted Purpose on the terms of this Licence.

1.2 For the purposes of clause 1.1, the **Permitted Purpose** for the Cambrionix API (forming part of the Software) is for use:

- (a) in connection with the LiveViewer local application (forming part of the Software);
- (b) with third party developed local applications (including those developed by you) that have similar functionality to LiveViewer (provided that those applications are not mobile applications, remote applications or cloud based applications); and
- (c) with "Connect".

1.3 You may (subject it falling within the Permitted Purpose, the restrictions in clause 2 and any third party terms that are applicable to the Software):

- (a) download, install and use the Software for your internal business purposes only (for the avoidance of doubt, "use" the Software shall mean loading the Software into temporary memory or permanent storage on the relevant computer, provided that installation on a network server for distribution to other computers is not "use" if the Software is licenced under this Licence for use and each computer to which the Software is distributed);
- (b) only use the Software in object code form;
